第一條 本法依據國立中央大學學分抵免辦法訂定。

Article 1 The Regulations are provided in accordance with the Guidelines of NCU Credit Exemption.

第二條 曾修習物理系博士班課程成績達 70 分（含）以上，且未計入學士班或碩士班畢業學分者，得申請抵免學分。

Article 2 Courses applied for credit exemption should be ones that were taken in Doctoral program of Physics and scored above C (70). Also, they should not be included as the required graduating credit of either master or bachelor degree.

第三條 曾修習物理系博士班課程成績達 70 分（含）以上，已計入大學部或碩士畢業學分者，不得抵免學分，但若為本系博士班課程，得申請免修。

Article 3 For courses taken in Doctoral program of Physics that scored above C (70) and were included as the required graduating credit of either master degree or undergraduate, they shall not be applied for credit exemption. However, if the courses are required ones from our doctoral program, they may be applied for course exemption.

第四條 申請抵免之課程若屬本系博士班課程則予以追認，若為本校或校外其他研究所課程，則須經過本系審核通過後追認之。

Article 4 We will recognized the application if the intended credits for exemption belong to our Doctoral Program. However, if they are from the graduate programs of other departments or other universities, they shall be recognized through test or verification.

第五條 符合本辦法第二條之條件者，抵免總學分不限，但在博士班修業期間必須修習至少 2 門本系研究所 2 學分（含）以上非專題課程。

Article 5 Applicants who meet the requirement in Article 2 may apply for credit exemption without any limit on the total exempting credit. However, they shall take at least two courses of non-seminars which contain two or more credits in this graduate program.

第六條 本辦法如有未盡事宜，依教育部及本校有關規定辦理。

Article 6 Other matters not stipulated in these guidelines shall be conducted in accordance with the Ministry of Education and the University's relevant regulations.

第七條 本辦法經物理系系務會議通過，並送教務會議核備後實施，修正時亦同。此辦法實施前已入學學生可選擇本辦法。

Article 7 These regulations and any amendments shall be approved by the Physics Department Affairs Meeting and shall become effective after the approval for future reference of Academic Affairs Committee Meeting. This regulation can also be applied on applicants that enter the school before the announcement of this regulation.
