- 第一條 本法依據國立中央大學學分抵免辦法訂定。
- Article 1 The Regulations are provided in accordance with the Guidelines of NCU Credit Exemption.
- 第二條 曾修習本校物理系及生物物理所或物理所碩士班課程成績達70分(含)以上,且未 計入大學部畢業學分者,得申請抵免學分。
- Article 2 Courses applied for credit exemption should be ones that were taken in Master program of Physics and scored above C (70). Also, they shall not be included as the required graduating credit of the undergraduate.
- 第三條 曾修習生物物理所碩士班課程成績達 70 分(含)以上,已計入學士班畢業學分者, 不得抵免學分,但若為本所碩士班必修課程,得申請免修。
- Article 3 For courses taken in Master program of Physics that scored above C (70) and were included as the required graduating credit of the undergraduate, they shall not be applied for credit exemption. However, if the courses are required ones from our master program, they may be applied for course exemption.
- 第四條 申請抵免之課程若屬本所及本校物理學系研究所課程則予以追認,若為本所及本校物理學系外其他研究所課程,則須經過本所審核通過後追認之。
- Article 4 We will recognized the application if the intended credits for exemption belong to our Graduate Program. However, if they are from the graduate programs of other departments or other universities, they shall be recognized through test or verification.

- 第五條 符合本辦法第二條之條件者,抵免總學分不限,但在碩士班修業期間必須修習至少 一門本所2學分(含)以上非專題課程。
- Article 5 Applicants who meet the requirement in Article 2 may apply for credit exemption without any limit on the total exempting credit. However, they shall take at least one course of non-seminars which contain two or more credits in this graduate program.
- 第六條 本辦法如有未盡事宜,依教育部及本校有關規定辦理。
- Article 6 Other matters not stipulated in these guidelines shall be conducted in accordance with the Ministry of Education and the University's relevant regulations.
- 第七條 本辦法經物理系系務會議通過並報教務會議核備後實施,修正時亦同。
- Article 7 These regulations and any amendments shall be approved by the Physics Department Affairs Meeting and shall become effective after the approval for future reference of Academic Affairs Committee Meeting. This regulation can also be applied on applicants that enter the school before the announcement of this regulation.
