第一條 本辦法依據本校「學分抵免辦法」訂定。

Article 1 The regulations are provided in accordance with National Central University Course Credit Waiver Guidelines.

第二條 抵免學分應於入學或轉所之第一個學期或第二學期校曆規定時間內辦理，限申請一次。

Article 2 Students (including newly-admitted and transfer students) who wish to apply for a course credit waiver should do so during their first or second semester in the University (or in the program) within the deadline specified in the academic calendar. The application may only be submitted once.

第三條 下列學生得申請抵免：

- 一、曾在大專院校就讀後再就讀學程者。
- 二、先修讀學分後考取修讀本學程者。

Article 3 The following students may apply for credit waiver:

- I. Students who had pre-session studies in other graduate institutes before enrolling our program.
- II. Students who had pre-session studies in this graduate institute before enrolling our program.

第四條 凡於大學部修習本學程課程成績達 80 分以上，但未計入大學部畢業學分數者，該課程得申請學分抵免。若為他校或本校其他系(所)研究生課程，則需經過本學程以考試或審查方式認定之，另須詳列抵免學科之課程綱要及成績單。抵免學分上限為本學程畢業學分數的二分之一。

Article 4 Courses applied for credit waiver should be ones that were in our program taken during undergraduate and scored above B (80) and have not previously been counted toward a student's minimum number of credit hours required for graduation. If the intended credits for waiver are from the graduate institutes of other departments or other universities (a foreign college or university should be recognized by the Ministry of Education), they shall be

recognized through test or verification of the relevant documents (an official copy of the course curriculum together with the transcript) by the Curriculum Committee. The number of credits for waiver shall not be more than half of the required graduating credits.

第五條 專題研究、書報討論、專題演講，不得申請學分抵免。

Article 5 Seminars, Book discussions, and Lectures shall not be included in the application of credit waiver.

第六條 抵免課程其成績不列入學期及畢業平均分數。

Article 6 Grades obtained from waived courses will not be counted toward the student's semester or graduation grades.

第七條 本辦法若有未盡事宜，悉依教育部及本校相關規定辦理。

Article 7 If there is any ambiguity or incompleteness in this regulation, please refer to related regulations set by the Ministry of Education and the National Central University.

If the intended credits for waiver are from the doctoral programs of other graduate institutes or other universities (a foreign college or university should be recognized by the Ministry of Education), they shall be recognized through test or verification of the relevant documents (an official copy of the course curriculum together with the transcript) by the Curriculum

Committee. The number of credits for waiver shall not be more than half of the required graduating credits.
